#### INVITATION FOR PUBLIC COMMENT/QUESTIONS

The Mayor asked if anyone wished to be heard.

Richard Cerne of 96 Keller Avenue believes that the cross walk located at Delaware Avenue and Victoria is illegal. The Mayor noted that Delaware Avenue is owned by New York State and that the DOT has never expressed a problem with the crosswalk. Mr. Cerne wants a "no parking" sign placed at the meters near the cross walk. He wants these meters bagged tonight.

Mr. Cerne also feels that he is being discriminated against because he has to hire outside

contractors to address his sump pump. He feels he should be allowed to do his own work as the

owner of his home. Mayor Mang instructed Mr. Cerne to go to the Building Department

tomorrow and ask for an application. It was noted that while single family homeowners may

perform work on their homes in some instances, the local law sets restrictions.

Mr. Cerne then said that he believes that the owner of 98 Keller has not secured required

permits. He also claims that when a power line fell on his lawn, a police officer did not ask to

see permits and would not allow him to file a report against his neighbor. He states that he has

contacted the NYS Attorney General, Erie County, Channel 4 and OSHA as he believes the

neighbor's shingles may contain asbestos. He stated that he has samples, which he'll get

analyzed.

As no one else wished to be heard, the meeting was adjourned.
