BOARD AWARDED A BID FOR THE 2023 CDBG ACCESSIBILITY IMPROVEMENT PROJECT.

Trustee Catalano moved to approve and award a bid for the 2023 CDBG Accessibility Improvement Project to Millennium Construction, Inc for a bid amount of \$538,025.
