# 2852 DELAWARE AVENUE – PARKINSON'S BOXING, LLC

# 33 VICTORIA BOULEVERD – SAINT PAUL'S ROMAN CATHOLIC CHURCH

The school building was sold and there is a small garage that has to be torn down to give Larry Bicz more storage space. The applicant wants to install a shed and a fence enclosure, which will house the air conditioning unit and totes.

The proposed shed will be seen from Delaware Avenue. The Planning Board wants landscaping around the shed.

The fence will be the same material as what is on the rest of the property. The color will be tan (creamy brown).

Thomas Fleming stated that he would like shrubs planted in front of the fence to soften the look from Delaware Avenue. He then moved to approve the requests, conditioned on shrubs being planted on the Delaware Avenue side of the fence and shed, and also conditioned that the fence can be no higher than six feet.

#### 2495 ELMWOOD AVENUE

The Architect David DeBoy and Executive Director Anne Kabott were present and are requesting a sign approval. The proposal is for an accent band with dimensional letters (silver). The sign would not be backlit.

Mr. DeBoy further explained that the scope of the project has expanded significantly because of the repair work. Funding is therefore limited.
